The above time table on RAJPURA TO LUDHIANA route is approved w.e.f. 07/06/22 as per the directions of Hon'ble Punjab & Haryana High court in the civil writ petition No.4326 of 2022 Dated 09/03/2022 and CM-6344-CWP-2022 in CWP-4326-2022 and in consideration to the Amnesty Scheme issued by the Government vide order no. 3/2/2011-2T2/318 Dated 04/05/2022. The Amnesty Scheme will be place till 05.08.2022.

Accordingly, the operators are being included in the Time Tables subject to the fulfillment of all conditions as provided under the aforesaid Amnesty Scheme.

The operators who fail to obtain NDC (NO Due Certificate) from the concerned authority regarding the deposit of arrears of taxes as per the Amnesty Scheme within the time specified therein, shall be automatically excluded from the respective Time Tables.
